After the result of the Trisomy 21with NT test it is expected that among 6516 women with the same data, there is one woman with a trisomy 21 pregnancy and 6515 women with not affected pregnancies. The calculated risk by PRISCA depends on the accuracy of the information provided by the referring physician.
