



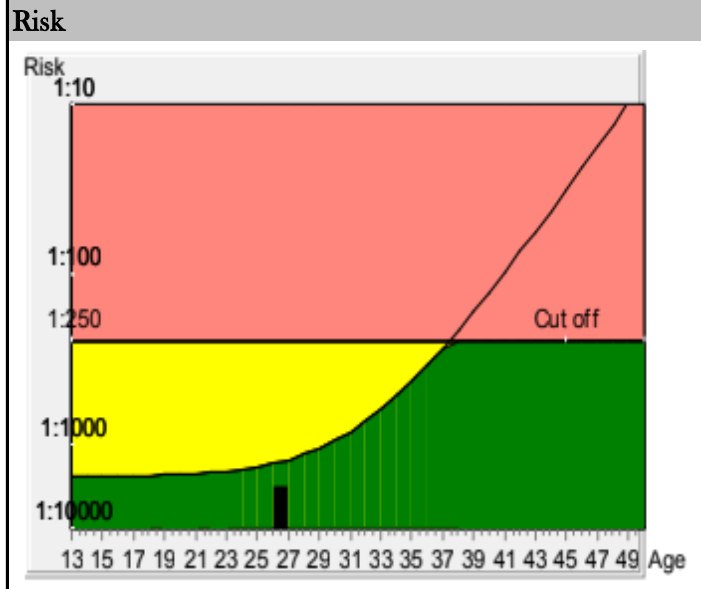

Risk
