After the result of the Trisomy 21 test (with NT) it is expected that among 4475 women with the same data, there is one woman with a trisomy 21 pregnancy and 4474 women with not affected pregnancies. The calculated risk by PRISCA depends on the accuracy of the information provided by the referring physician.
